## Goals of Meeting:

- · Broadening the Weed Control Committee with new members
- Enlisting volunteers to help with bog management
- Compiling a list of issues and concerns to be addressed
- Enhanced communication: keeping all Adirondack Lake property owners informed via email and postings on the Town of Indian Lake website

#### **History of Adirondack Lake:**

- Originally Pinney Pond
- Formed by a stone dam built in 1910 to become Lake Byron
- Dam rebuilt in the 1930s by the Civilian Conservation Corp and renamed Lake Adirondack
- Encompasses 200 acres; the lake water flushes about every 10 months
- Rooted aquatic plant growth has been a complaint since the late 1960s, with a variety of methods employed to control the weeds.
- Then (1960s): excessive weeds / Today: too few weeds

#### **Weed Control Committee Overview:**

- Formed in 1982 with the primary goal of addressing the Lake's 67% weed infestation
- Five WCC volunteers appointed by the Town Board
  - Brian Farrell, Chairman
  - Ernie Pollman (Adirondack Lake Rd)
  - Dick Wooley (Adirondack Lake Rd)

- Mickey Merwin (Bennett Rd)
- George Anderson (Bennett Rd)
- Funded by the Weed Control Tax
  - Contributors:
    - Lakefront property owners
    - Property owners with Deeded Lake Rights (taxed at ¼ of the rate of 100' of lake frontage) => to be confirmed
    - Town contributes \$3,000/yr
  - Balance: \$89,700.55
  - Intended use of funds:
    - Weed management
    - Bog removal expenses, including boat maintenance and rope
    - Mudflat bog removal
- · Various attempts to manage weeds have included:
  - Lake water drawdowns of from 3 to 9 feet (to freeze weeds)
  - Mechanical harvesting
  - Aquatic herbicide 2,4-D
  - Lime application
  - Aquashade (shading dye), which yielded the nickname "Lake Ty-D-Bol"
  - Grass Carp (5,500 total from 1996-2012)
- WCC coordinated a 2017 Adirondack Lake Aquatic Plant survey by a biologist
- Upcoming: 2018 Fish survey (via netting) to confirm bass and pike populations and rationale for applying for a DEC stocking permit

- Bog boat information:
  - Property of the Weed Control District
  - Registered & insured by the Town of Indian Lake
  - Operated by Brian Farrell with the assistance of volunteers
  - Fuel & maintenance refunded by the Town (from WC tax fund)
  - Docking location TBD for 2018 (Brian Farrell's property?)

# **Annual Weed Control Survey Review:**

The DEC and HCSWCD conduct an annual Adirondack Lake Plant Survey

- Primary reasons for survey: Studying existing plant life is necessary to deal
  with Invasive species, helpful for weed control assessments and essential to
  determining the viability and justification required by law for DEC & APA to
  issue Bass, Trout, Pike, Walleye and Grass Carp stocking permits.
  - Benefits to Weed Control Committee: monitoring carp and percentage of weed coverage
    - There are no plans to add more Grass Carp in the near future
    - The August 2017 DEC/HCSWC Survey found overall plant density since first stocking has dropped by more than 95%
    - The biologist performing the 2017 Aquatic Plant Survey reported "10% plant life with new growth evident"

- There is no charge for the DEC/HCSWCD survey
- Follow-up questions & concerns on this topic:
  - Get a recommendation from the DEC (or other) as to the ideal balance of weed density control needed to support, maintain and reproduce a robust Bass and Northern Pike fishery and other wildlife, while also keeping Adirondack Lake friendly for recreational activities (boating, swimming)
  - In addition to completing surveys, request recommendations for improvement from the various organizations and biologists
  - Share results of surveys with the Weed Control tax payers
  - Add additional volunteers to the Weed Control Committee

# Dam Report:

- Engineering assessment = complete
- · Project is in the Request for Qualifications stage
- DEC provided a schedule (currently behind)
- Funding has been secured
- Rebuild will include a full wall replacement; size of new spillway TBD
- A temporary cofferdam with sheet pilings will be in place during construction
- · Walkway (part of Comprehensive Plan) is not included in the initial rebuild

## **Next Steps:**

- Communication:
  - Shari Rowe is collecting names and contact info from willing volunteers
  - Meeting notes will be shared online through the Town's website (www.townofindianlake.org)
  - Ad hoc committee will determine a means of sharing additional information with the Adirondack Lake Weed Control Tax payers (email / website / facebook / mailings)
    - An email address has been created to communicate with the WC Tax payers: adklakecommittee@gmail.com
- Other topics of discussion to be addressed in future meetings:
  - Monitoring and managing invasive species
    - Purple loosestrife (=> contact Nature Conservancy or HCSWCD)
    - Is someone looking out for Milfoil or considering boat inspections?
  - Snails & clams increasing
  - Beavers increasing and wreaking shoreline (=> contact DEC)
  - Protection of loon nesting sites
  - Reinstitution of a horsepower limit on boat motors

# Adirondack Lake Aquatic Weed Control District Summer Meeting July 24, 2018

The meeting was called to order at 7:35PM with an introduction of the Weed Board members (Brian Farrell, Ernie Pollman, Richard Wooley, George Anderson, Mickey Merwin – absent) and the Ad Hoc Committee members (Shari Rowe, Rita Rozboril, Warren Tunkel, Glenn Sullivan, Ed and Marty Ford – absent).

Shari introduced Caitlyn Stewart, Conservation Educator with the Hamilton County Soil & Water Conservation District. She delivered a presentation on "Love Your Lake" – sources of aquatic pollution and best management practices to prevent it. Topics covered were raingardens, shore buffers, use of low phosphorus products, proper maintenance of septic systems and the dangers on the ecosystem of poisons.

This was followed by a question and answered session from those in attendance.

The Advisory Board and the Ad Hoc Committee met prior to this meeting. Rita Rozboril spoke briefly on what was discussed: bog removal, lake health, issues with the carp and the importance of open communication between the Advisory Board and the home owners on the lake regarding lake management.

This was followed by Glenn Sullivan, Certified Lake Manager with SOLitude Lake Management who spoke on "The Current State of Adirondack Lake". He expressed why we need to be concerned about the health of the lake now and the importance of acting responsibly to restore it back to a healthy balanced ecosystem. Topics covered were encouraging growth of healthy native plants by decreasing the carp population thus enabling productive weed growth. The weed growth currently runs about 5% in our lake, and the DEC feels a normal healthy coverage should be around 30%. A question was asked about the mud bogs and he responded that they cannot be removed because they are considered to be wet lands. He discussed the various native plants that need to return and that their seeds still exist in the bottom of the lake and could return naturally. He stressed that surveys have been regularly done and the lake will continue to be monitored yearly.

Mr. Sullivan's talk was followed by questions and concerns. These included carp harvesting, balanced weed growth, our bog boat status (currently a contractor has been hired by the Advisory Board to remove bogs using his boat at a cost of about \$500 per day), and the need to encourage open communication between the Advisory Board and the homeowners/weed tax payers regarding lake issues.

Before the meeting ended, a vote was taken of everyone present as to whether a carp harvesting event should take place in cooperation with the Indian Lake Fish and Game Association. The response was 35 yes and 6 no. Warren Tunkel will be meeting with the Fish and Game Assoc. on July 25th to discuss details.
